Class size is limited to 12 dogs, which will split into 3 groups of 4 dogs by size.

Classes will be outdoors and will be held unless there is a heavy rain or lightning. Come prepared to work in light rain if necessary. Wear comfortable shoes. Bring lots of tasty small dog treats! Bring a variety of treats, some with higher value than the others. Examples are string cheese, cubes of sliced turkey, pizza crust, etc. Be inventive! Bring a non-choking collar for your dog and a 6 foot leash.

Directions:

From Rt 221, turn on Rt 621 Cottontown Rd at CVS. Go one mile and bear right as name changes to Rt 660, Hawkins Mill Road. House is about 1.25 miles further, on the right.

From Coffee Rd, turn onto Hawkins Mill Rd at the new Stables subdivision. We are about 2 miles from The Stables, on the left.

From Wiggington Rd at The Stables, turn left for about 2 miles. House is on the left

I certify and represent that the dog entered is not a hazard to persons or other dogs. The Dog Owners Training Club of Lynchburg, Inc. has the right to refuse to have this dog in the training class for cause which the club shall deem to be sufficient.

I agree to hold the Dog Owners Training Club of Lynchburg, Inc., its members, directors, officers, agents, instructors and owners of premises upon which the event is held, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the Agility Training premises or grounds of or near any entrance thereto, and I personally assume all responsibility and liability for any such claim; and I further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage, or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself, or on account of damage to property, arising out of or in consequence of my participation in this Agility Training, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may alleged to have been caused by negligence of the aforementioned parties or any of the employees or agents, or any other persons.

I assume sole responsibility for and agree to pay all expenses for repair of property damaged by myself or by my dog while on the training premises, or for veterinary care for any damage caused by myself or by my dogs to dogs belonging to the Smotrels.

Dogs will be kept on leash at all times except when required to be off lead in training or when running the agility course.
